a) The National Company Law Tribunal, Ahmedabad Bench vide its order dated November 27, 2020 has approved the Composite Scheme of Arrangement between Infibeam Avenues Limited (formerly known as Infibeam Incorporation Limited) (Demerged company 1) and NSI Infinium Global limited (Demerged company 2) and Suvidhaa Infoserve Private Limited (Resulting Company 1) & DRC Systems India Limited (Resulting company 2) and their respective shareholders and creditors.

b) Appointed Date: April 01, 2020

c) Effective date: December 02, 2020

d) Date of Allotment: December 15, 2020



e) The National Company Law Tribunal, Ahmedabad Bench vide its order dated November 27, 2020 has approved the Composite Scheme of Arrangement between Infibeam Avenues Limited (formerly known as Infibeam Incorporation Limited) (Demerged company 1) and NSI Infinium Global limited (Demerged company 2) and Suvidhaa Infoserve Private Limited (Resulting Company 1) & DRC Systems India Limited (Resulting company 2) and their respective shareholders and creditors.

In terms of the Scheme and pursuant to Sections 230 to 232 read with Section 66 of the Companies Act 2013 and Section 2(19AA) of the Income-tax Act, 1961, the demerged undertaking along with all its assets, liabilities, contracts, agreements, employees, permits, records etc shall without further act, or deed be demerged from Demerged company has been transferred & vested in the Resulting company 2 as a going concern.

In Consideration of the above demerger, the Resulting company 2 has issued & allotted 1 (one) equity share of Rs. 10/- (Rupees Ten Only) each of Resulting Company 2 for every 412 (Four hundred and Twelve) equity shares of Rs. 1/- (Rupee one only) each held by such shareholder in Demerged company 1 as on Record date.
