- d) Date of Allotment: February 02, 2021
- e) The Hon'ble National Company Law Tribunal, Hyderabad Bench vide its order dated December 24, 2020 has approved the scheme of Arrangement between Ortin Laboratories Limited (Demerged Company) and Vineet Laboratories Limited (Resulting Company) and their respective shareholders and creditors.

In terms of the Scheme and pursuant to Sections 230 to 232 read with Section 66 of the Companies Act 2013 and Section 2(19AA) of the Income Tax Act, 1961, the API Intermediates Division (Unit II) of the Demerged Company has been transferred to and vested with the Resulting Company with the Appointed Date of April 1, 2020.

In consideration of the transfer and vesting of the API Intermediates Division (Unit II) of the Demerged Company, 52 (Fifty-two) Equity shares of Rs. 10/- each (fully paid-up) of the Resulting Company has been issued and allotted for every 100 (Hundred) Equity Shares of Rs. 10/- each (fully paid-up) held by the shareholders in the Demerged Company.
