## **Sub: Shifting of Securities to Z Category**

Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 (Erstwhile SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2018/77 dated May 3, 2018) members of the Exchange are hereby informed that the below mentioned Company have been observed as Non-compliant with Regulation 31 (i.e. Non-submission of Shareholding Pattern) of the SEBI (LODR) Regulations, 2015 for two consecutive Quarters i.e. March 31, 2020 and June 30, 2020. Therefore, trading in securities of the below mentioned Company is eligible to be transferred to 'Z' Category ('BZ' series). However, securities of below mentioned company were suspended from trading w.e.f. March 12, 2020 as per the Exchange Circular No. NSE/CML/43727 dated March 03, 2020. Therefore, trading in securities of the company shall remain suspended till further notice.
