Sub: Shifting of securities to Z category

Pursuant to SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 (Earlier SEBI circular No. SEBI/HO/CFD/CMD/CIR/P/2018/77 dated May 3, 2018), members of the Exchange are hereby informed that the following companies are observed as non-compliant with Regulation 76 of the SEBI (LODR) Regulations, 2018 (i.e. non submission of reconciliation of share capital audit report) for two consecutive quarters i.e. December 31, 2019 and March 31, 2020.
